Department Details

DEPARTMENT OF PHARMACOLOGY:-

The pharmacology department lays strong emphasis on research while imparting education in pharmacology, toxicology & other related subjects. A primary objective of Pharmacology is to investigate the fundamental aspects of molecular bio-regulatory mechanism of the cell and understand how the new drugs act for treatment of diseases. Toxicology examines toxicity and adverse effects of newly developed drugs, mechnisms of chemical agents and how they produce mutagenicity, carcinogenicity, teratogenicity and neurological disorders.

THE DEPARTMENT HAS TWO SEPARATE LABORATORIES:-

ANATOMY AND PHYSIOLOGY LAB I:- It is established to understand the Human Anatomy, Physiology and Pathology of diseased state of the patient with the help of charts, models including human skeleton & various types of apparatus.

PHARMACOLOGY LAB II:- It consists of equipment to investigate the activity of various drug samples, and such instruments as Rota Rod, Electro-convulsiometer, Plethysmograph, Analgesiometer, Histamine chamber and Actophotometer.

DEPARTMENT OF PHARMACOGNOSY:-

"Pharmacognosy is the science that deals with medicines derived from natural sources" Pharmacognosy is a specific discipline that deals with the rapid developments in the knowledge and utilization of medicinal substances of biological origin (Plant, microorganism and animal products) used for human and veterinary purposes.

This subject provides information about the principles and procedure used in the identification, authentication, extraction and isolation of active constituents by chromatography techniques, purification and development of herbal formulation and assay methods for the isolated constituents. Focus is also centred on pharmacopoeial regulations, ICH, EU guidelines and principles of good manufacturing practices. The Pharmacognosy lab is equipped with Projection microscope, Soxihlet apparatus, Clevenger's apparatus, Stage micro-meter and aculometers. Hot air oven together with many crude drugs, charts and models.

HERBAL GARDEN:-

The College has established a Herbal Garden to teach students about the evaluation & extraction of drugs obtained from plant source. This includes a variety of plants like Datura, Calotropis, Azadirachta indica, Cannabis sativa and Withania somnifera.

Department Details

DEPARTMENT OF PHARMACEUTICAL CHEMISTRY:-

The department of pharmaceutical chemistry is one of the central important branches of the Institute. It is equipped with state of the art facilities to undertake academics in Bachelor of Pharmacy course. In the frontier area of phytochemical research, the focus is laid on isolation, characterization & evaluation of biological activities both by in-vitro & in-vivo models. Analysis of drugs and pharmaceutical chemicals forms the backbone of research and development in pharmaceutical industry. The department focuses on training the graduate students on how to use the modern and new instrumental analytical techniques such as HPLC, UV-Visible Spectroscopy, Fluorimetry and Flame photometry. Special emphasis is laid on the implementation of good laboratory practices and analytical skills. The department is actively involved in developing new analytical methods and their validation, characterization and quantitative estimation of possible impurities in various dosage forms. The department has a Pharmaceutical Chemistry Lab I (Inorganic / Organic Chemistry Lab), Pharmaceutical Chemistry Lab II (Medicinal Chemistry Lab) and Pharmaceutical Chemistry Lab IV (Central Instrumentation Facility).

DEPARTMENT OF PHARMACEUTICS:-

Pharmaceutics is concerned with the strategies by which biologically active compounds are presented to the body so as to elicit an optimal response. It includes the design, preparation and testing of drug delivery systems. The department has Machine Room, Pharmaceutics Laboratory I (GP/DP labs). Pharmaceutics Laboratory II (Unit Operation Lab) & Pharmaceutics Laboratory III (Micro biology lab). The machine room is well equipped with latest machines generally encountered in Pharmaceutical Industry like Coating Pan, Hand Operated Single Punch machine, Dissolution Rate Test Apparatus, Disintegration Test Apparatus, Refrigerated Centrifuge, Deep Freezer, Mechanical and Sieve Shaker, Filter Press, Venturimenter and Orifice Meter, Friability Test Apparatus, Granules Drier, Capsule Filling Machine and Mechanical Stirrer,

PHARMACEUTICAL MICROBIOLOGY LABORATORY:-

The Aseptic Room of Microbiology lab has facilities like BOD Incubators, Laminar Air Flow, UV Cabinet, Deep Freezer, Digital Oven, Incubators, Incubator Cum Shakers, Bacterial Colony Counter & Autoclaves.

The Pharmacy Department has also successfully completed projects sponsored by ALL INDIA COUNCIL OF TECHNICAL EDUCATION.

Admission Procedure

1. ADMISSION

- 1.1. Admission to B.Pharm. 1st Semester in 1st year and lateral admission in B.Pharm. 2nd year in 3rd Semester (for diploma holder candidates only) made as per the rules prescribed by the Academic Council of the Dr. APJAK Technical University, Lucknow.
- **1.2.** Admission on account of migration of a candidate from any other University to Dr. APJAK Technical University is not permitted.

2. ELIGIBILITY FOR ADMISSIONS:

2.1. ADMISSION THROUGH ENTRANCE EXAMINATION:

(I) Candidates who have passed 10+2 intermediate securing 50% marks from UP Board or from other Boards with Physics & Chemistry as compulsory subject along with one of the following subjects:-

SUBJECT

Mathematics /Biology are eligible for Admission to 1st year of B.Pharmcy course offered by private colleges/institutions of UP.

(ii) Candidates who have passed 2 year Diploma (with minimum 50% marks) from institutions recognized by the UP Board of Technical Education in Pharmacy are only eligible for admission to 2nd year of B.Pharm.

2.2. DIRECT ADMISSION ON VACANT SEATS AT INSTITUTION/COLLEGE LEVEL:

The eligibility criteria for direct admission on seats remaining vacant in 1st year after entrance examination counseling shall be such as may be notified from time to time.

COLLEGE RULES AND REGULATIONS

• All the students will have to register their names at the beginning of each semester. Failure to do so will debar them from all facilities.

ATTENDANCE

Each student is required to have at least 75% attendance in each of the theory & practical classes; otherwise he/she will be debarred from appearing in the end semester examination under AKTU norms.

REMOVAL FROM COLLEGE ROLLS

The name of the student will be automatically removed from the college roll if

- 1. He/she fails to pay up his/her dues in time
- 2. He/she remains absent from classes or hostel for more than 15 days without prior infimation.
- 3. He/she, otherwise eligible, does not deposit his/her examination or admission form without prior permission from the Principal.

DISCONTINUATION OF STUDIES

Ragging in any form by any student inside or outside the Innovative College of Pharmacy campus or hall of residence is strictly prohibited. As per the judgement of Honourable Supreme Court ragging in any form is a punishable heinous crime.

As per the latest amendment to UGC Regulations on curbing the menace of ragging in higher educational institutions, ragging is defined as-"Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance nationality, regional origins, linguistic identity, place of birth, place of residence, and economic background".

Innovative College of Pharmacy has constituted Anti-Ragging Committee and Anti-Ragging Squad for preventing ragging in college campus and in Hostel. CCTV cameras are installed at all locations known to be vulnerable to occurrences of ragging incidents.

"Anti-Ragging Helpline" means the Helpline established by the UGC under UGC Regulations on curbing the menace of ragging in Higher Educational Institutions, in 2009 under UGC Act 1956. Anti-Ragging Measures

PUNISHMENTS:-

As per the UGC and PCI following actions can be taken by the Institute depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the Institution. The possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:-

- 1. Suspension from attending classes and academic privileges
- 2. Withholding/withdrawing scholarship/fellowship and other benefits
- 3. Debarring from appearing in any test / examination or other evaluation process
- 4. Withholding results
- 5. Debaring from representing the institution in any regional, national or international meet, taurnament, youth festival, etc.
- 6. Suspension/expulsion from the hostel
- 7. Cancellation of admission
- 8. Rustication from the institution for the period as decided:
- Expulsion from the institution and consequent debaring from admission to any other institution for a specified period
- 10. Fine ranging between Rupees 25,000/- and Rupees 1 lakh
- 11. Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.






