Between

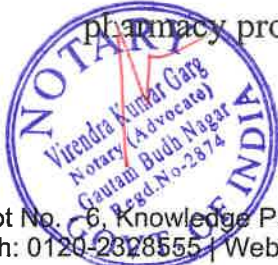

The parties hitherto agree as follows:

1. Party one declares that **Aryan Ayurvedic Medical College and Hospital** is a 60 bedded hospital, with a minimum of 60 beds for General Medicine Department.

3. Party one agrees to provide preceptors required to train the students of pharmacy programs for their Hospital Training & Project Work.



4. The prospective students will be allowed to undergo training in the following specialty departments.

- Medical dispensing
- Dressing
- Pediatrics
- Gynecology and Obstetrics
- Psychiatry
- Skin and VD
- Orthopedics

(As per course training and project work)

5. Both parties will provide the academic support and necessary infrastructure for pharmacy programs and takes the overall responsibility for smooth conduct of the programs.

6. Both parties will support to each other for conducting health awareness programs like Health Checkup Camps, Blood Donation Camps and health related Seminars etc.

7. This agreement is to be in effect at least for five years from the time of its endorsement by both the parties.

8. The officials representing Dean/Medical Superintendent/Medical Director/CEO of the hospital and Principal/Dean of Innovative College of Pharmacy are signing this MOU to achieve the beneficial objectives for pharmacy programs.
