Preamble

- Share educational resources, including libraries, laboratories, and other facilities, to support the academic and research activities of both institutions.

5. Community Engagement:

- Collaborate on community outreach programs and awareness campaigns to promote the benefits of pharmacy and homoeopathy.

Responsibilities of the Parties

1. Innovative College of Pharmacy:

- Provide access to its faculty, facilities, and resources as required for the collaboration.
- Ensure that all participating members adhere to the agreed terms and conditions of this MoU.

2. Homoeopathy University - Jaipur:

- Offer support and access to its faculty, resources, and facilities for the agreed collaboration activities.
- Ensure that all participating members adhere to the agreed terms and conditions of this MoU.

Duration and Termination

This MoU will be effective from the date of signing and will remain in effect for a period of five years, unless terminated earlier by either party with three months written notice. The MoU may be extended upon mutual agreement of both parties.

Confidentiality

Both parties agree to maintain the confidentiality of any proprietary or sensitive information exchanged during the collaboration and use it solely for the purposes outlined in this MoU.

Amendments

Any amendments or modifications to this MoU must be made in writing and signed by authorized representatives of both parties.



Dispute Resolution

Any disputes arising from or related to this MoU will be resolved through mutual negotiation and, if necessary, mediation.



Innovative College of Pharmacy

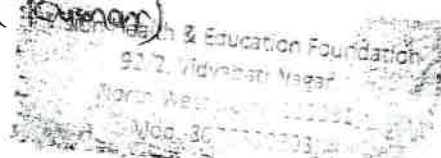
- Provide necessary infrastructure and support for vision health programs.

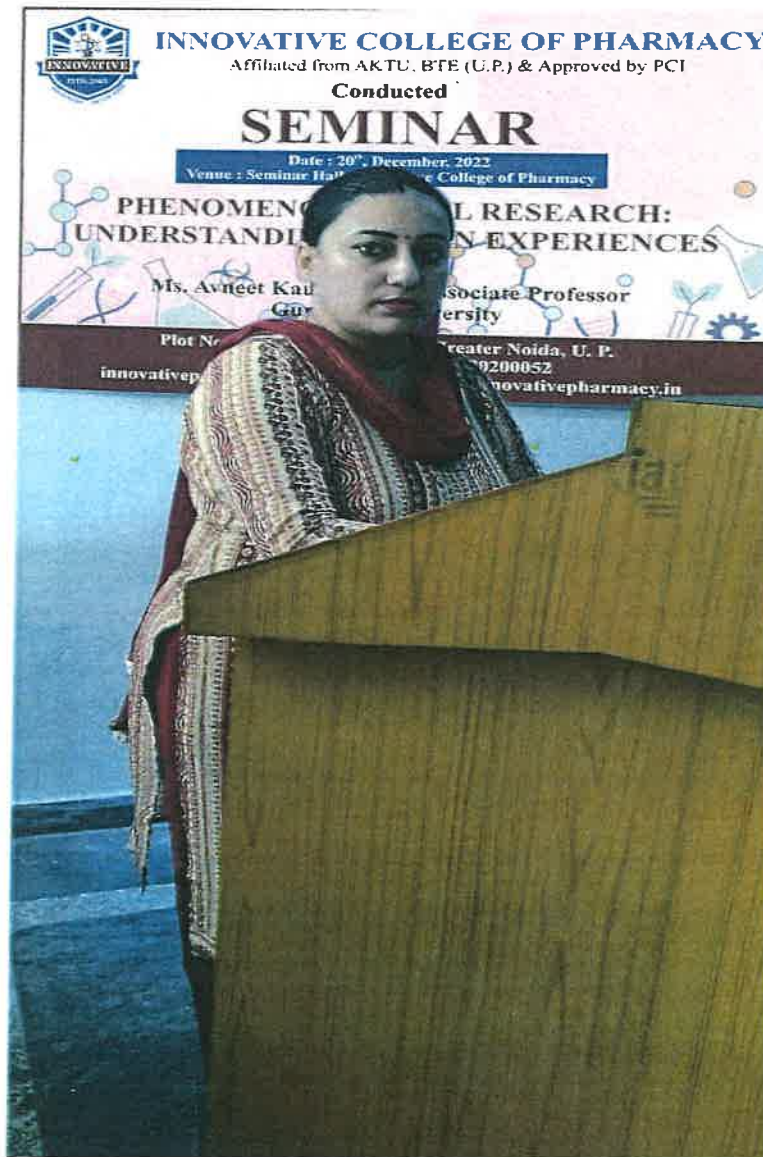


Figure1: Photographs of honorable speaker presented valuable lecture on "Phenomenological Research: Understanding Human Experiences"
